Educational and non-theatrical copies of Fictionville Studio titles are available directly for purchase from Fictionville Studio for use by individual libraries, colleges, K-12 schools, media centers, and other non-profit educational organizations. The purchase of these titles includes non-theatrical Public Performance Rights.

## Screening Rights:

Non-theatrical Public Performance Rights allow the purchaser to screen the film for groups of 50 or less. These rights are guaranteed in perpetuity for the life of the copy. No admission can be charged and screenings may not be open to the public.

Please contact Fictionville Studio to rent a film or to host a screening if any of the following conditions apply:

- a screening to an audience greater than 50
- a screening that is open to the general public
- a screening where an admission fee is a factor
- your titles are available to more than 1 institution

Please note: Per copyright law, a DVD purchased through our home video department or any other consumer retail site does NOT include Public Performance or Educational Rights and cannot be used for screenings, and neither a home video or non-theatrical/educational DVD may be copied.

## Purchase & Payment

An educational institution may purchase any of the titles with Non-Theatrical Public Performance rights by submitting the order form to us via email, fax or mail.

A confirmation email and invoice will be sent to the purchaser within one week of the receipt of the order. Payment by check, money order, or credit card (Visa, Mastercard, and American Express, via Paypal) or the receipt of a purchase order is required before shipment. Therefore, we ask that you complete your purchase at least two weeks before the intended date of use.

## Shipping

Orders will be shipped within two days of receipt of payment or purchase order. All shipments will incur a \$5 shipping charge for domestic orders and \$7 for international orders.

## Previews

Previews are available for a \$15 fee per title (plus shipping in both directions) for 30 days for purchase consideration. The preview fee will be deducted from the sale price if a title is purchased within 30 days. If the preview dvd is not returned within 30 days, the institution will be billed the full price of the dvd. Previews do NOT include public performance rights and may not be used for instructional purposes.

## Returns, Exchanges & Cancellations

Requests for refunds and exchanges must be made in writing within 14 days of receipt. DVDs that arrive damaged will be replaced at no cost, provided the defective material is returned promptly. Fictionville Studio must be notified of any cancellations at least two weeks prior to date of use—shipping fees will not be refunded if materials have already been shipped.

### Do you accept Purchase Orders?

Yes! Feel free to send an authorized purchase order to us via email, fax or mail, and we will gladly bill you with the shipment.

### Why are your prices so high?

The prices listed in our catalog are for institutional use. Unlike home videos which include only the license to watch a film in your home, the institutional price listed in our catalog comes with the license to screen films in a classroom setting or for library loaning.
